
Do not just design buildings based on your feelings or emotions, use the building codes and design responsibly.

INTRODUCTION

Making sure a building, whether new or old, satisfies the minimal requirements established by local, regional, or national building codes is known as "building code compliance." These codes are mandated by law and are meant to guarantee:


- Safety (egress, fire prevention, structural integrity, etc.)
- Sanitation and health
- Efficiency of energy
- Accessibility
- Resilience and sustainability





WHAT ARE BUILDING CODES?

Building codes are sets of regulations and standards that govern the design, construction, and occupancy of buildings to ensure safety and public welfare.



WHY ARE THE CODES SO IMPORTANT?

A framework for **responsible architecture** is provided by building codes.

They make sure that design innovation does not compromise human dignity, safety, usability, or the rule of law.








What is this compliance about?

Building code compliance is a critial aspect of any construction project. It is the cornerstone of safety, quality, and sustainability in the built environment.




In essence, it involves adhering to a set of regulations and standards. These are established by local, state, federal authorities to ensure that buildings are safe, functional, and environmentally friendly.



BUILDING USE & OCCUPANCY CLASSIFIATION

According to the Nigerian Building Code Revised Edition 2018 section 4.2.1, every building or structure whether existing or hereafter erected shall be classified as follows:

I. GROUP A - ASSEMBLY

II. GROUP B - BUSINESS AND PROFESSIONAL

III. GROUP E - EDUCATION

IV. GROUP F - FACTORY AND INDUSTRIES

V. GROUP H - HIGH HAZARD

VI. GROUP I - INSTITUTIONAL

VII. GROUP M - MERCANTILE

VIII. GROUP R - RESIDENTIAL

IX. GROUP S -STORAGE

X. GROUP U - UTILITY AND MISCELLANEOUS
